# I. Executive Summary

### II. Introduction

On June3, 2014,72.41% of Livermore voters approved the MeasureG ParcelTax, authorizing the Livermore Valley Joint Unified School District (LVJUSD) to levy an annual parceltax of \$138 on each parcel of taxable real property. The stated purpose of MeasureG is to help the LVJUSD provide advance course in math, science and engineering help keeps chools well-maintained, attract and retain highly qualified teachers provide elementary school science and technology specialists and keep class room technology and instructional material sup-to-date. At the time of voter approval, MeasureG included the two charters chools operate by the Tri-Valley Learning Corporation in Livermore, Livermore Valley Charter School and Livermore Valley Charter Preparatory High School.

MeasureG thusensuredhat Livermoreschools would continute receive a stable, reliable, local sourceof funding. Overall, the LVJUSD servesover 13,800 students in transitional kindergarten through 12th grade at nine elementary campuses, wo K-8 schools, three middle schools, two comprehensive high schools, and two alternative schools. Specifically, the MeasureG funds would be used to:

- x Provide advanced courses in mattience and engineering,
- x Keepschoolswell maintained,
- x Attract and retain highly qualified teachers,
- x Provide elementarsychool science antechnologyspecialists,
- x Keep class room technology and instructional material sup-to-date and,
- x To the extent that funds are available, to maintain academic programs, including the purchase of instructional equipment materials, and supplies.

This ParcelTax commenced July 1, 2015 and remains in effect for seven fiscal years, with exemptions from the ParcelTax for citizens over the age of 65 if such citizens applied for an exemption. As part of Measure G, a Citizens' Oversight Committee ("Committee") is convened annually to ensure that proceeds of the tax are spentwisely and only for the purposes named in Measure G.

This report covers the fourth fiscal year (FY2018-2019) of the ParcelTax and details the Committee's assessment from the funds were dispersed in this fiscal/ear.
